- Proposal: Change the Master of Business Administration major. Remove the following courses from the list of elective course options: BUS 674, FIN 631, MGT 606, MKT 610. Change respective catalog language for elective requirements.
- Proposal: Change catalog language under the section "Students may take either of the courses listed below as part of the Required Courses." Under the listed courses, add: "Students who complete both courses will be allowed to count one of the courses as an elective."
- Proposal: Change catalog language relating to MBA admissions policy. Replace the following:
 "Applicants who have earned a graduate degree from a fully accredited institution of higher
 education are eligible for admission without submission of GMAT or GRE scores." See attached
 for new text.
